Requirements for the attainment of a teacher licensure vary by state and may involve more requirements than successful degree completion, such as, but not limited to applications, fees, and licensure examinations. Completion of a degree from an accredited institution of higher education in Arkansas, such as Crowley's Ridge College (CRC), will not alone qualify a graduate to obtain a teaching license in any other state. This statement does not exclude an individual from seeking or receiving licensure by reciprocity, should a state offer this pathway.

CRC is accredited by the <u>Higher Learning Commission</u> and offers the following programs that have been approved for licensure recommendation in the State of Arkansas by the <u>Arkansas</u> <u>Department of Education's Division of Elementary and Secondary Education Office of Educator Effectiveness and Licensure</u>. Therefore, students who successfully complete the below programs and pass all associated licensure exams are eligible to be recommended for Arkansas Educator Licensure in the degree area.

Bachelor of Science in Elementary Education; Licensure eligible for Elementary (K-6)

Bachelor of Science in Health and Physical Education; Licensure eligible for PE and Health (K-12), and Coaching endorsement (K-12)

Students desiring teacher licensure outside of Arkansas should check with the appropriate state's licensing authority to ensure that CRC's program requirements meet eligibility for licensure in that jurisdiction. Contact information for the state departments of education can be found in the table below.

Additionally, students enrolled in CRC's educator preparation programs, named previously, are only approved for field experiences

(inclusive of observations, internships, teacher residency, etc) within the state of Arkansas.
